Core Solutions:

- Digital Artwork Passports: Unique biometric fingerprints to authenticate artworks, reducing counterfeiting risks (which account for up to 40% of the market) and generating revenue through fees.
- Condition Reports: Automated, blockchain-secured reports for insurance and valuation, reducing costs by 70% and time by 65%.
- Secure NFT+ Marketplace: Enhanced NFTs with multi-chain compatibility, supporting minting and trading in fiat and cryptocurrency.
- Art Insurance and Logistics: Developed in collaboration with Munich Re, these services integrate with condition reports and tracking tools to ensure transparency and security.

Market Impact:

- The global art market generates \$65 billion in transactions annually, with \$15 billion in online sales growing at 5% per year.
- Digitizing processes saves stakeholders 84% in costs and 99% in time for transactions like ownership transfers and restorations.
